This Memorandum of Understanding (MoU) is made and entered into by and between:

Khalsa College Patiala, a premier educational institution located in Patiala, Punjab, India, represented by its Principal, Dr. Dharminder Singh Ubha, hereinafter referred to as "First Party,"

AND

Bakliwal Foundation College of Arts, Commerce & Science, Vashi a renowned institution of higher education located in the Vashi, Navi Mumbai, represented by its Principal, Dr. Sharadkumar Shah, hereinafter referred to as the "Second Party."

WHEREAS, both institutions are committed to fostering academic collaboration and promoting international understanding;

NOW, THEREFORE, the parties have reached the following understanding:

1. Purpose

The purpose of this MoU is to establish a framework for mutual cooperation in the fields of education, research, faculty and student exchange, and cultural understanding.

2. Areas of Collaboration

The cooperation may include, but is not limited to:

- Exchange of faculty and research scholars
- Exchange of students for academic and cultural enrichment
- Joint research activities and publications
- Organization of joint seminars, workshops, and academic meetings
- Sharing of academic resources and best practices

3. Implementation

Each institution will appoint a coordinator to monitor and facilitate the implementation of the activities under this MoU. Specific programs and exchanges will be subject to mutually agreed upon terms in separate written agreements.

4. Funding

Each party shall bear its own costs in relation to travel, accommodation, and subsistence unless otherwise agreed upon in writing.

5. Duration and Termination

This MoU shall be effective from the date of signing and shall remain in force for a period of five (5) years. It may be renewed by mutual consent of both parties. Either party may terminate this MoU by giving a notice of at least three (3) months in writing.

6. Legal Effect

This MoU is not legally binding and does not create any legal obligations. It is an expression of mutual intentions to collaborate in good faith.

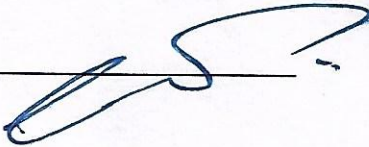

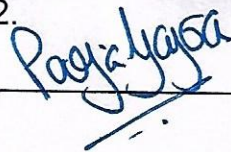
